Cardinal Stefan Wyszyński University in Warsaw, user of the Omega-PSIR software, undertakes to ensure the accessibility of its website in accordance with the provisions of the Act of 4 April 2019 on digital accessibility of websites and mobile applications of public entities. Status of digital accessibility

The website is partially compliant with the Act of 4 April 2019 on digital accessibility of websites and mobile applications of public entities due to the incompatibilities or exemptions listed below:

- some elements of the website may have too little contrast;
- the website may have a distorted heading hierarchy;
- content published by third parties (authors) may not comply with the requirements of the Law;
- selected films and audio materials may not have transcription and/or audiodescription;
- the documents have been adapted to WCAG requirements to the extent permitted by technical conditions. On the website, next to the link to each document in the repository, there are links which, in the absence of a file version compliant with WCAG requirements or in the event of noticing insufficient compliance, allow for automatic sending to the website's editorial office of information about the need to adapt the file to WCAG requirements.

Handling requests and complaints related to accessibility

Everyone has the right to request the digital accessibility of a website, mobile application or any element thereof. It is also possible to request that the information be made available in alternative forms, such as reading a digitally inaccessible document, describing the content of a film without an audio description, etc. The request should include the details of the person making the request, an indication of which website or mobile application is involved, and a method of contact. If the requesting person reports the need to receive information in an alternative form, they should also specify the form of this information.

The public entity should comply with the request immediately and no later than within 7 days. If it is not possible to meet this deadline, the public entity shall immediately inform when it will be possible to comply with the request, provided that this deadline cannot be longer than 2 months. If it is not possible to ensure accessibility, the public entity may propose an alternative way to access the information.

If an entity refuses to comply with a request to provide accessibility or alternative access to information, a complaint may be filed against such action.

After all possibilities have been exhausted, the complaint can also be sent to the Ombudsman.

Communication and information accessibility

Pursuant to Article 9 (3) and (4) of the Act of 19 August 2011 on Sign Language and Other Means of Communication (Journal of Laws No. 209, item 1243), Cardinal Stefan Wyszyński University informs that it provides eligible persons with the possibility of using the assistance of a sign language interpreter and the following means of supporting communication by e-mail, which can be directed to the following address <u>m.stanczuk@uksw.edu.pl</u>.

An eligible person should indicate their wish to be assisted by a sign language interpreter or other form of communication at least 3 working days before visiting the Office (excluding emergencies) via an appointed person, fax or e-mail.

In order to improve the service to the entitled person, it is advisable that the notification specifies the subject matter of the case and indicates the method of contact in matters related to arranging a visit date, form of communication, etc.
