

ORDINANCE

No. 42/2023 of the Rector of the Cardinal Stefan Wyszyński University in Warsaw dated 2 August 2023

on the amount of fees for educational services for postgraduate study programs and other forms of education in the academic year 2023/2024

Pursuant to Article 163.2 of the Act of 20 July 2018 – Law on Higher Education and Science (*Dziennik Ustaw* 2023, item 742, as amended) and § 25.2 (1)(b) of the Statute of the Cardinal Stefan Wyszyński University in Warsaw, it is hereby ordered as follows:

§ 1.

- 1. For postgraduate students and participants in other forms of education at the Cardinal Stefan Wyszyński University in Warsaw, hereinafter referred to as "University", the following amounts of fees for courses in the academic year 2023/2024 are hereby established:

§ 2.

- 1. Postgraduate students and participants in other forms of education pay a one-time fee for the entire academic year no later than 7 business days before the start date of classes or in the case of semester installments no later than 7 business days before the start of the relevant semester.
- 2. The head of another form of education will provide information to the Bursar's Office about the amount of installments, in the case of payment in semester installments, no later than 14 days before the start of the education, in order to fill out the price lists in the USOS system.
- 3. The condition for entering a person on the list of postgraduate students or participants in another form of education and enrollment for the next semester is making the payment within the time limits specified in paragraph 1.

§ 3.

- 1. Fees for educational services are paid to the individual IPM bank account generated in the USOSweb system.
- 2. The payment date is the date when the amount is credited to the bank account referred to in paragraph 1.
- 3. Failure to pay fees on time will result in the accrual of statutory interest for each day of delay.
- 4. Payments made after the due date will be credited first towards the principal amount and then



towards accrued interest on late payments. In settlements concerning educational services, the sole basis for the identification of payments made by a postgraduate students or participant in another form of education is the individual IPM bank account number.

§ 4.

- 1. Resignation or removal from a postgraduate study program or other form of education during the academic year does not grant entitlement to receive a refund of fees paid, subject to paragraph 3.
- 2. Resignation from educational services provided by CSWU must be submitted in writing to the main office of the unit organizing the relevant postgraduate study programs or other form of education.
- 3. The amounts paid are refunded only for semesters of education at postgraduate study programs and other forms of education that have not yet started.

§ 5.

- 1. The rules for refunding fees mentioned in § 1, paid by postgraduate students or participants in other forms of education, are set forth in paragraphs 2 to 5.
- 2. The fee paid for postgraduate studies or another form of education shall be refunded only in the cases mentioned in paragraphs 3 and 4, at the request of a postgraduate student or participant in another form of education submitted in writing to the main office of the unit organizing the relevant educational service.
- 3. In the case of resignation, 100% of the fee paid for the semester is refunded, provided that the request is submitted before the start of classes in the relevant semester to which the refund pertains.
- 4. If the postgraduate study program or other form of education is not launched, 100% of the fee shall be refunded.
- 5. The refund referred to in paragraph 2 shall be made in the form of a transfer to the bank account indicated in the application, according to the formula established by the University, minus the transfer fee.

§ 6.

Information on the rates of fees for educational services provided in postgraduate studies and other forms of education is published in the Public Information Bulletin on the University's website http://bip.uksw.edu.pl.



§ 7.

In matters related to payment for educational services provided as part of postgraduate study programs and other forms of education that are not regulated herein, the decisions shall be made by the vice-rector for student affairs.

§ 8.

The amount of fees for educational services provided as part of postgraduate studies and other forms of education, charged from postgraduate students and participants in other forms of education who began postgraduate studies and other forms of education in the academic year 2022/2023 and earlier, is set forth in the agreement with the University.

§ 9.

The Ordinance shall enter into force as of the day of its adoption.
